**Staffing Updates 2025:** Wayne Prout on leave for term 1 2025 – Kim Watkins Acting HOD Maths, Dani Lloyd will continue as acting HOD English as Mrs Tracey Goodrum has retired after 25 years at Bray.

#### Students

**2024 Results** – Very good results with Edward Churchill awarded Dux of school 2024 with a 99.10 ATAR – highest in Bray history. 100% QCE attainment. Many excellent VET achievements. <u>A 1.8% improvement in A-C data from 2023 to 2024 – great result!</u>

**Enrolment Figures**: 1879 Students enrolled with 360 new year 7s. Once again, a new school record for BPSHS. Significant pressure on our facilities at present – little opportunity for out of catchment enrolments last year but new building may allow some ability to take some for mid 2025/26.

**Mobile Phones:** Students have been great in complying with the second year of this directive. Updated Student Code of Conduct tabled for signing.

**Student Hub:** space for students to visit for support around attendance, behaviour, uniform, bullying issues and wellbeing – located near the tuckshop. YLCs for 2024 – Miss Kassel Year 7; Mrs Knight Year 8; Mrs Harvey Year 9; Mr Champney Year 10, Mrs Morrisey Year 11 and Mrs Martir Year 12. Mrs Kennedy also again for Admin support.

**ARTIE Program and Car:** Bray Park welcomed the ARTIE program in week 2 along with a school car sponsored by RACQ. The program aims to improve Indigenous student attendance and outcomes as well as proving opportunity for students to do hours towards their driving licence. Floyd Aubrey is our ARTIE mentor.

**Yearbook 2024:** At printer now- great historical record and thanks to Lisa Fischer for her terrific work to compile. We post to all 2024 Seniors who have ordered.

**Swimming Carnival:** Terrific day of sportsmanship, competition, fun and house spirit at Lawnton Pool last Tuesday. Students all had a fun day and Fire house proved too dominant in and out of the pool.

**Student Investiture**: Present badges tomorrow to our 2025 leaders on 18 February. Leaders are working hard this term to progress their initiatives well supported by Mrs MacDougall who is taking the role of Student Council Co-ordinator. Lovely morning tea to share with proud parents – thanks to year 11 hospitality. 2017 School Captain and now physiotherapist Mr Matthew Ashton is our special guest.

**Chaplaincy Trivia Evening:** Registrations open for the 15 March event. A great night planned for a good cause to support our students.

**Japan Trip 2025:** Planning well underway with 30 students attending in September. Miss Emily Baldry is leading a team of 4 teacher traveling with the students. Opportunities for fundraising through the year.

Innovate STEM Tour 2026 – P and C Committee support request for proposed New Zealand Innovate STEM Tour for 2026. The opportunity will provide Bray Park SHS students with a once in a life time chance to immerse in a different culture, participate in a NASA approved Space Camp and experience vast natural landscapes typical to New Zealand's plate tectonic boundary region.

**Problem Solving Challenge:** 10 schools and over 35 teams to attend BPSHS as we host the annual STEM focused challenge. Teams of four students from years 5,6,7 and 8 vying for the honours. "Decoding the Universe" is this years' theme.

**Gifted and Talented Team:** Champions in each faculty have been appointed who promote activities and strategies to nurture our enthusiastic and creative minds.

**2025 Musical:** Rehearsals are continuing for our "High School Musical" - dates are 12/13/14 June in the hall.

Music Ensembles and Dance Troupes: all are in full swing with many students involved in before and after school rehearsals.

**Leadership Training Days:** Very positive leadership development day held in week 2 of Term 1. Year 11/12 leaders worked towards their legacy through the Peer Power Program. All came away excited for the year ahead.

**Primary Principal's Morning Tea** – On Thursday 6<sup>th</sup> March our local feeder school principals will visit the 15 year 7 classes to see how they are going at high school. Students really appreciate this follow up and are proud to show their new school.

**Co-Curricular Activities Program**: passionate teachers offering a range of lunchtime, before and after school activities for students – Clubs in Robotics and Chess, Music, Maths and English Tutoring, Sport, Social and Cultural activities.
